## Failure to supply these documents will result in unnecessary delays.

Your Progress Drawdown Request will be assessed, and funds released within 5 business days, upon the receipt of all required documentation.

If you are requesting your **FIRST** or **FINAL** progress payment, a valuation will be completed by [us/Advantedge] prior to the payment being processed.

Please allow up to 5 business days further for the funds to be deposited, depending on the receiving financial institution.

## Important information:

This form authorises us to make a progress payment to your builder in accordance with your progress payment schedule. Do not sign this form and give it to us or your broker until you have received all necessary invoices from your builder and you are satisfied that the work has been done in accordance with your building contract. Any request for variations that differs to your progress payment schedule must be approved by the lender.
